Clinical Progression: Students must maintain a "C" or better in HC124 and HC126 lab to participate in HC126 clinicals

Grade Requirement: A minimum grade of "C" must be earned in this course to be eligible to graduate from a WDT program and to progress to courses that require this course as a prerequisite.
